### REPRESENTATIVE MATTERS

Daphne's representative matters include:

- Defended employer and individual defendants in a putative federal class action alleging surreptitious audio recordings of private

conversations in violation of federal and state wiretapping statutes, 42 U.S.C. Section 1983, California Invasion of Privacy Act, Article I of the California Constitution and common law privacy laws. Originally filed in Alameda Superior Court, we removed the action to federal court and then transferred it to United States Central District Court in Santa Ana. After Plaintiffs rebuffed our attempts at early resolution, we obtained dismissal of the employer on a motion to dismiss, defeated Plaintiff's motion for class certification on the remaining claims against the individual defendants, and obtained a voluntary dismissal of the entire action after filing a motion for summary judgment and Rule 11 motion for sanctions.

- Represented an employer in its appeal of the California Public Employee Retirement System's determination to apply the penalty provisions of Government Code Section 20305 to a class of 3,000+ claimants and defended the employer in a three-week administrative hearing before an ALJ at the Office of Administrative Hearing. Negotiated a favorable settlement prior to the ALJ's issuance of the statement of decision.
- Represented an employer and individual defendants in a putative federal class action alleging violations of the ADA Title II and the Rehabilitation Act of 1973. Obtained dismissal of all claims against individual defendants and damages claims and achieved a creative settlement of the class action claims without any monetary payment.
- Represented a leading research scientist, officer, and director in a complex product liability/unfair competition action involving a series of 32 individual actions, 3 putative class actions, and unfair practice claims pending in three different courtrooms in the San Diego County Superior Court. Defeated class certification, Burke resolved all claims against the client through a combination of summary judgment motions and voluntary dismissals.
- Represented a manufactured housing company in a putative nationwide class action alleging unfair competition and product liability. Obtained dismissal of entire action after defeating plaintiff's motion for class certification.
- Represented a county in a dispute regarding pension benefits and independent contractor status. Prevailed after a 3-day administrative hearing.
- Represented employer in an unfair labor practice charge alleging retaliation. Obtained dismissal of the complaint and underlying charge following a three-day administrative hearing at PERB. Upheld on appeal.
- Represented a public entity employer in an action alleging race discrimination, harassment, and whistleblower retaliation. Obtained summary judgment.
- Obtained dismissal of a First Amendment and retaliation action

against a public entity following a successful Anti-SLAPP motion.  
Successful recovery of attorneys' fees.

- Obtained summary judgment in a defamation action, which was upheld on appeal.
- Obtained dismissal of action alleging breach of contract, labor code violations, and intentional misrepresentation following successful demurrer and motion to strike.
