- Defended an internationally known and local historical site against claims of defective design and code violations causing blindness and brain damage. This trial resulted in a defense verdict.
- Defended a City against claims that a major intersection, which coincided with the entrance to a world-class and celebrity-known hotel, was defectively designed causing catastrophic injuries. Using detailed plans from the intersection designed, obtained summary judgment based on a design immunity defense.

### **Assault and Battery by Public Employee**

- Defended a municipal transit authority against claims of elder abuse and severe battery resulting in a shattered life. Presenting a solid defense, exposing the fabrications of the evidence and the true limit on the damages incurred, the verdict resulted in 1% of the amount sought.

### **Employment Disputes**

- Defended a utility company against claims of wrongful termination arising out of whistle-blowing and the failure to promote a senior executive who claimed retaliation for refusing to participate in illegal activities. After a two-month trial, obtained a defense verdict.
